SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 Hereby makes the following Order:-

This Order shall come into operation on the 19th July 2018 and shall remain in force for eighteen months. The effect of which will be to introduce a temporary prohibition of vehicles in the roads specified in Schedule 1 to this Order. The restrictions shall apply when indicated by traffic signs.

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

1. This Order shall come into operation on the 19th day of July 2018 and shall remain in force for eighteen months. The restrictions shall apply when indicated by traffic signs.
2. Save as provided in Article 3 of this Order no person shall cause or permit any motor vehicle to enter, proceed or wait along the lengths of road specified in Schedule 1 to this Order
3. Nothing in Article 2 of this Order shall apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform;
 - (ii) Police, Fire and Ambulance emergency service vehicles.
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
4. This Order may be cited as Somerset County Council (Jurston Lane, Wellington) (Temporary Prohibition of Vehicles) Order 2018.
