#### Role purpose

As a member of the Resources, Strategy & Transformation management team, the Head of Commercial Investment works with other senior managers to shape the council's asset management strategy and decision-making, and to improve, co-ordinate and lead the work of the department.

The Head of Commercial Investment is responsible for the management and strategic development of Somerset Council's portfolio of commercial investment property, and also takes a lead role managing the council's investments in limited companies where these have a primarily commercial purpose. This includes ensuring effective control of tenancies, income collection and asset management for the commercial property portfolio, and responsibility for the implementation of investment or divestment decisions. As the council's strategic lead in this specialist area, the postholder takes a lead role (working with the Executive Director Resources, Strategy & Transformation, S151 and Deputy Section 151 officers, other senior finance managers and Executive Members) in developing and implementing commercial investment / divestment strategies in relation to the property investment portfolio and related companies.
