Role Purpose

The Landlord and Compliance Specialist provides expert leadership and technical oversight for all landlord property safety compliance across Somerset Council's retained housing stock. This includes statutory responsibilities for asbestos, water hygiene, radon, and fire safety, ensuring that all properties meet or exceed legal and regulatory standards.

This niche role is pivotal in managing a team of Case Managers and operational staff, overseeing high-risk activities, and ensuring that the Council's duty of care is fulfilled. The postholder ensures that compliance strategies are implemented effectively, risks are mitigated, and that the Council's housing assets remain safe, legally compliant, and fit for purpose.

Accountabilities

Lead and manage the delivery of landlord property safety compliance, including asbestos, water hygiene, radon, and fire safety, across over 6,000 council-owned properties.

Line manage a team of Case Managers and operational staff, providing coaching, development, and performance oversight.

Undertake strategic planning and operational oversight of statutory inspections, surveys, and remedial works, ensuring compliance with legislation and best practice.

Act as the Council's technical expert on landlord compliance, advising senior leaders, Members, and regulatory bodies.

Manage contracts and budgets (approx. £500k) for asbestos, water hygiene, and radon safety, ensuring value for money and timely delivery.

Maintain and analyse compliance data, producing reports for senior management and external audits.

Ensure accurate records are maintained for all compliance activities, including asbestos registers, water testing, and fire safety documentation.

Manages a compliance budget of approximately £500,000.

Leads on high-risk activities including asbestos removal, radon remediation, and water hygiene.

Regularly engages with senior leaders, contractors, and regulatory bodies.

Requires site visits, including work at height and in confined spaces.
