#### Role purpose

The Senior Landscape Officer will play a pivotal role in the Planning Directorate, contributing to the sustainable development and enhancement of Somerset's natural and built environments. This role involves providing expert advice on landscape matters, ensuring that development proposals align with local and national policies. The postholder will be responsible for assessing the landscape and visual impacts of planning applications, developing landscape strategies, drafting landscape policies for inclusion in statutory development plans, and promoting high-quality landscape design. The role requires collaboration with various stakeholders, including developers, community groups, and other council departments, to achieve the council's vision for a greener, more sustainable Somerset. The post holder will also support the Placemaking Team Manager in delivering strategic projects and initiatives that enhance the county's landscape and public spaces.

### Responsibilities

- Provide expert advice on landscape and visual impact assessments for planning applications.
- Support the preparation, implementation, and review of statutory development plans by drafting and/or inputting to the formulation of policies and assessing the impact of site allocations.
- Develop and implement landscape strategies, design codes, masterplans and policies in line with local and national guidelines.
- Promote high-quality landscape design in development proposals.
- Collaborate with developers, architects, and other stakeholders to ensure landscape considerations are integrated into planning processes.
- Conduct site visits and surveys to assess landscape conditions and inform planning decisions.
- Prepare and present reports to planning committees and other relevant bodies.
- Prepare and present evidence as an expert witness at public examinations, local inquiries and appeals in so far as it relates to landscape.
- Monitor and review the implementation of landscape conditions and agreements.
- Support the Placemaking Team Manager in delivering strategic landscape projects.
- Engage with community groups and the public to promote landscape initiatives and gather feedback.
